As *Interim Provost*, I serve as the chief academic officer of the university, with responsibility for teaching, learning, scholarship and research across the Danforth campus. Direct reports include the 6 academic deans, the vice chancellor for research, the university librarian, the vice provost for undergraduate admissions & financial aid, the vice provost for faculty advancement & institutional diversity, the directors of university wide centers and institutes, the registrar, the Title IX office, the institutional research office, and the office of student success.

As *Vice Provost*, I had responsibility for creation and oversight of programs designed to enhance cross-school interdisciplinary research and teaching (e.g., the Bring Your Own Idea program and the Cross-School Teaching Grant program); creation and oversight of the TableTalk program, which seeks to enhance undergraduate student-faculty interaction outside the classroom; “Beyond Boundaries,” a signature freshman & sophomore curricular experience that capitalizes on the university’s strengths across schools; serving as the provost’s liaison to five university-wide centers and institutes, advising on faculty and staff hiring, retention, budget, programming, fundraising, and personnel issues; chairing review committees for university-wide and provost office-based centers; chairing the Teaching & Learning domain committee for IT (overseeing the

selection and implementation of a new Learning Management System, and a pilot process for a new lecture capture/streaming solution).

During 2016-17, I served as *Leader of the University Libraries*, where I supervised 145 staff members including a 7-member senior leadership team, and administered an annual budget of \$24 million. Major challenges for the year included re-opening lines of communication with the provost's office and with faculty; promoting transparency and democratic governance processes with staff; overseeing a significant construction project; sustaining the libraries' relationships with donors, its National Council, and with external collaborating organizations; and transitioning to a newly hired University Librarian effective July 2017.

As *Director of the Center for the Interdisciplinary Study of Work and Social Capital* (<http://www.law.wustl.edu/centeris/>), I worked with an interdisciplinary Advisory Board drawn from across Washington University to sponsor scholarly roundtables, work groups, workshops, conferences, and speaker panels designed to enrich the research and learning of affiliated faculty and their students by connecting them with research on similar topics in other disciplines. The Center initiated and facilitated the production of scholarly output from its events, including books, journal issues, and other publications.
